School Donation

School Security

St. Pius X Council 11101 donates over **\$5,000.00** to St. Pius X School to secure the existing building.

With the participation of many knights, several fund raisers and many man hours; the council was able to accomplish this deed. The biggest by far was the Belk Charity Sale. Without this event the council could not have achieved this goal. A special thanks to all who worked the event.

The school contracted with the local access control company to install a card access system on high use doors. All the exterior locks were changed to a secure key that the school controls. No more borrowing a key and going to the local key shop to get a copy. All access must be

done through card access. If the school wants you to be in the building, you will get a card. Keys are no longer available. A brother knight donated his time to change all the locks on the building. This enables greater security for all the students and staff.

The buildings are able to be locked at all times offering security for all who attend. Unless you are known, one does not get into the school.

The same is true for the Connolly Gym. It now has card access thus limiting the use to outside groups not in the parish who use the gym for basketball games.

This by far is the single largest donation our council has ever made to the school.



Youth Group Donation

Our council held several pancake breakfast over the past months. With overwhelming success, we were able to donate **\$1200.00** to the parish youth work camp this year.

The youth assisted our brother knights with the breakfast in the capacity of dining room help and cleanup. Under the direct su-

pervision of the youth consular, many of our parish youth took part in this great effort. By the looks on the faces of the youth, everyone had a good time doing so.

The council hopes to continue utilizing their help with other projects.

All the council efforts are directed to Building the Domestic Church.


On Saturday, **April 28** there will be a **Second Degree** at
